# **Instructions**

The online form captures the information required by the department to assess and manage your application for services and funding.

The first page of the portal application page contains the following instructions.

## Completing your application

The application consists of separate pages as shown in the navigation menu on the left hand side of the portal page. You can navigate between pages using the menu or the buttons at the bottom of each page.

A red asterisk \* indicates a mandatory question. A warning message may appear if you have not completed all of the mandatory questions or if there is an issue with information you have entered.

## Saving your responses

You can save your changes at any time by using the Save button.

To prevent you losing your work you should save often. The portal will time out after 30 minutes if you do not save. Typing or moving your mouse does not reset the time out.

You must use the Save and Continue button to validate the information on each page. If you use the menu to navigate between pages, you will be prompted on the final page to go back and validate all of the information you have entered. A green tick indicates a validated page.

You can modify saved responses up until you submit your application.

You may invite others to assist in completing your application via the application summary page. To do this:

# A. Program selection

Before you start your application, we need to first identify what type of entity is applying.

This grant opportunity will run over 4 years from 2022-23 to 2025-26.

The grant opportunity is part of the Australian Government's \$49.5 million comprehensive investment to enhance resilience of the domestic Diesel Exhaust Fluid (DEF) market.

Up to \$16.15 million is available for this grant opportunity.

The objective of the program is

- to support sovereign capability in manufacturing to produce TGU for the domestic DEF market in the period 2023 to mid-2026
- produce TGU that is compliant with the ISO 22241 specification for the production of DEF, or as certified by Original Equipment Manufacturers (OEMs) for use as a DEF.

There is no minimum or maximum grant amount, but grants cannot exceed the amount of available funds.

You should read the <u>grant opportunity guidelines</u> and <u>sample grant agreements</u> before filling out this application. We recommend you keep the guidelines open as you are completing your application so you can refer to them when providing your responses.

You may submit your application at any time up until 5.00pm AEDT on 28 February 2023. Please take account of time zone differences when submitting your application.

We cannot accept late applications under any circumstances.



# B. Eligibility

Provide a summary of the expected project outcomes.

#### Project alignment with program objectives

  - retaining and strengthening sovereign manufacturing capacity and capability.
- how your project will benefit the DEF market, including contributing to resilience in the Australian market and enhancing security and competition.
