Do not use this document as your application form. You will need to submit an application using the online form once the grant opportunity is open to applications

Instructions

The online form captures the information required by the department to assess and manage your application for services and funding.

The first page of the application page contains the following instructions.

Completing your application

The application consists of separate pages as shown in the navigation menu on the left hand side of the portal page. You can navigate between pages using the menu or the buttons at the bottom of each page.

You must use the Save and Continue button to validate the information on each page. If you use the menu to navigate between pages, you will be prompted on the final page to go back and validate all of the information you have entered. A green tick indicates a validated page.

A red asterisk * indicates a mandatory question. A warning message may appear if you have not completed all of the mandatory questions or if there is an issue with information you have entered.

You can save your changes at any time by using the Save button. To prevent you losing your work you should save often. The portal will time out after 30 minutes if you do not save. Typing or moving your mouse does not reset the time out.

Participants

You may invite others to assist in completing your application via the application summary page. To do this:

- Select the Participants button
- Enter the details

An email will be sent to the participant inviting them to assist with your application.

Submitting your application

You must complete every page of the application before you can submit.

You must also read and agree to the declaration which advises you of your responsibilities.

Check all your answers before you submit your application. After you submit, it will no longer be editable.

A. Program selection

We need to first identify what type of entity is applying.

Some programs we offer allow entities without an ABN to apply. The form is designed to accommodate these entities. However for this grant opportunity, an ABN is mandatory. If you do not have an ABN this grant opportunity will not appear in the program selection at the bottom of the first page and you will not be able to continue.

If you are a trustee applying on behalf of a trust we will need details of both the trust and trustee.

Before you start you should have the following details ready if they are applicable to you.

If you do not have an ABN we will ask you why you do not have one. You should note the following.

If you are entitled to an ABN and do not provide it to us, we will be required to withhold 47 per cent from any grant awarded. If you intend to apply for an ABN you should do so before starting your application as you cannot update these details in the application form. If you apply for an ABN after you start your application you will need to start again.

A.1. Program selection

You must select from a drop-down menu the program that you are applying for.

- Field 1 select MRFF – Rapid Applied Research Translation
- Field 2 select MRFF – Rapid Applied Research Translation

When you have selected the program, the following text will appear.

The objective of this grant opportunity is to provide grants of financial assistance to support Australian medical research and medical innovation projects that:

- use existing knowledge to develop, test and implement new approaches for the translation of research findings into health care and health interventions that have potential for broader applicability;
- address a clearly defined gap in the implementation of best practice health care and health interventions to improve health outcomes; and

- involve all stakeholders relevant to the research and its translation in its conceptualisation, design and implementation, including health care consumers and providers.

Two streams of funding are available based on the geographic location of the lead organisation:

- **Stream 1:** Organisations based in urban areas (any area according to the Modified Monash Model Locator¹)
- **Stream 2:** Organisations based in rural areas (MM2 or above according to the Modified Monash Model).

The intended outcome of the research funded by this grant opportunity is to improve the health and wellbeing of Australians by accelerating implementation of research knowledge and outcomes into health care and practice.

You should read the [grant opportunity guidelines](#) and [sample grant agreement](#) before filling out this application.

You may submit your application at any time up until 5.00pm AEDT 6 May 2021.

B. Eligibility

We will ask you the following questions to establish your eligibility for the MRFF 2020 Rapid Applied Research Translation Grant Opportunity.

Questions marked with an asterisk are mandatory.

Is your organisation incorporated in Australia? *

A legal entity is an entity in its own right that has capacity to enter into legally binding agreements or contracts, assume obligations, incur and pay debts, sue and be sued and be held responsible for its actions.

Is your organisation one of the following bodies? *

- a medical research institute
- a university
- a corporate Commonwealth entity
- a corporation (including businesses and not for profits)

Do you have the mandatory evidence from your board or CEO that there is support for the project, that you can complete the project and meet the costs of the project not covered by grant funding? *

Select Yes or No from the drop down list

You will be required to up load evidence later in the form.

C. Applicant address

C.1. Applicant street address

You must provide your street address

When you start typing the address in the field you can select the correct one from the drop down list that appears. If it is not there you can enter manually.

C.2. Applicant postal address

You must provide your postal address

When you start typing the address in the field you can select the correct one from the drop down list that appears. If it is not there you can enter manually.

D. Applicant financials

D.1. Latest Financial Year Figures

- Has the applicant existed for a complete financial year?
- If no, enter the number of months completed in the financial year to date.

D.2. Recent trading performance

You must provide the following financial information about the applicant organisation.

We collect the following data from all applicants across all grant programs. We use this data to better understand your organisation and to help us develop better policies and programs.

All amounts must show a whole dollar value e.g. \$1 million should be presented as \$1,000,000. The turnover value must be that of the entity that is making the grant application (the 'applicant'), regardless of whether the entity belongs to a consolidated group for tax purposes.

These fields are mandatory and entering \$0 is acceptable if applicable for your organisation.

- Sales Revenue (Turnover)

Total revenue from the sale of goods and services, as reported in your organisation's Business Activity Statements (BAS).

- Export revenue

Total revenue from export sales, as reported in your organisation's BAS.

- R&D expenditure

Expenditure on research and development, i.e. creative work undertaken on a systematic basis in order to increase the stock of knowledge, including knowledge of man, culture and society, and the use of this stock of knowledge to devise new applications.

- Taxable income

Taxable income or loss as per the applicant's Business Income Company Tax Return form.

- Number of employees (headcount)

Number of individuals who are entitled to paid leave (sick and holiday), or generate income from managing the business. This should include working proprietors and salaried directors.

- Number of independent contractors (headcount)

Number of individuals engaged by the business under a commercial contract (rather than an employment contract) to provide employee-like services on site.

E. Project information

On this page you must provide the detailed information about your proposed project.

If your application is successful, we will publish some grant details on [GrantConnect](#). Published details include:

- *a brief project description and its intended outcome*

E.1. Project title and description

Provide a project title.

Your response is limited to 75 characters including spaces and does not support formatting. This data will be published if your application is successful.

Provide a brief project description.

Your response is limited to 750 characters including spaces and does not support formatting. This data will be published if your application is successful.

Ensure your project description focuses on your project's key activities and outcomes. Explain what it is you are going to do and how it will benefit your organisation.

E.2. Detailed project description and key activities

This information will be included in your grant agreement if your application is successful.

Provide a detailed description of your project including the project scope and key activities.

Your response is limited to 5000 characters including spaces and does not support formatting.

E.3. Project outcomes

This information will be included in your grant agreement if your application is successful.

Provide a summary of the expected project outcomes.

Your response is limited to 5000 characters including spaces and does not support formatting.

E.4. Grant Stream

You must select one of the following two streams

If you are selecting Stream 1 or Stream 2: Organisations based in urban and rural areas please check your project is within the Modified Monash Model Location [Locator Tool](#)

Stream 1: Organisations based in urban areas (any area according to the Modified Monash Model Locator²)

E.5. Project duration

- Estimated project start date

The project length will be calculated by the start and end dates you enter. Your project can be no longer than 5 years. Project start date not before 1 July 2021

E.6. Project milestones

You must breakdown your project into milestones. You should include the key activities occurring at each milestone. The start date of milestone 1 is the expected project start date. The end date of your last milestone activity will be the project end date. You will be required to complete the following fields. You can add up to 20 milestones.

- Milestone title

Your response is limited to 100 characters including spaces and does not support formatting.

- Description

Your response is limited to 750 characters including spaces and does not support formatting.

- Estimated start date
- Estimated end date

E.7. Project location

You must provide the address where your project will be undertaken and the estimated percentage of project value expected to be undertaken at that site. If you have multiple sites you must add the address of each site.

A project site must be a street address not a postal address.

- Project site address
- Estimated percentage of project value expected to be undertaken at site

The first site listed must be the primary site address irrespective of the percentage of time work is undertaken at that site.

F. Project budget

F.1. Project budget summary

You must provide a summary of your eligible project costs over the life of the project in a table as shown below.

Grant funding requested

You will be asked to enter the amount of grant funding you are requesting. Validations will limit your request to be within the grant opportunity guidelines.

G. Project partners

You must provide details about your project partners.

For details about project partner refer to the grant opportunity guidelines.

You must appoint a lead organisation. Only the lead organisation can submit the application form and enter into the grant agreement with the Commonwealth. The application should identify all other members of the proposed group and include a letter of support from each of the project partners.

Each letter of support should include:

- *details of the project partner*
- *an overview of how the project partner will work with the lead organisation and any other project partners in the group to successfully complete the project*
- *an outline of the relevant experience and/or expertise the project partner will bring to the group*
- *the roles/responsibilities the project partner will undertake, and the resources it will contribute (if any)*
- *details of a nominated management level contact officer*
- *include details of co-contribution of cash funding or in kind in support of the project.*

Attach your letter of support.

H. Assessment criteria

We will assess your application based on the weighting given to each criterion and against the indicators listed beneath each criterion. We will only consider funding applications that score satisfactorily against each criterion as these represent best value for money.

The amount of detail and supporting evidence you provide should be commensurate with the project size, complexity and grant amount requested. You should define, quantify and provide evidence to support your answers.

To support your responses you must include mandatory attachments later in the application.

Your response is limited to 5000 characters for each criterion including spaces and does not support formatting.

H.1. Assessment criterion 1 (40 points)

Project impact

Assessment criteria as per the guidelines

You should demonstrate this by identifying

- a. how your project will support the rapid adoption of research into health service delivery in a priority area identified by health services and consumers
- b. the extent to which your project will deliver outcomes that are a priority for the Australian public, including evidence of engagement and involvement by all stakeholders relevant to the research and its translation during conceptualisation, development and planned implementation of your project
- c. partnerships with health service delivery partners that will support implementation of study findings into practice, as quickly as possible
- d. how the research will provide outcomes within the grant period
- e. the extent to which your project includes new and innovative approaches that have broader applicability
- f. the extent to which your project builds on and supports other initiatives, if applicable.

You should demonstrate how the outcomes or results you have identified against the MRFF Measures of Success are relevant and meaningful to the goal and aims of the Rapid Applied Research Translation Initiative.

H.2. Assessment criterion 2 (30 points)

Project methodology

You should demonstrate your proposed approach to delivering the project by providing:

- a. your project plan, including:
 - an outline of the activities you will undertake
 - appropriate milestones, performance indicators and timeframes for delivery
 - the governance structures in place for the project
- b. a project feasibility analysis.

H.3. Assessment criterion 3 (30 points)

Capacity, capability and resources to deliver the project

You should demonstrate this by providing details of:

- a. your access to, and/or a feasible plan to recruit, an appropriate, multi-disciplinary team, with proposed key project personnel, their skills and experience clearly articulated, along with explanations of how their skills and experiences are important to the success of your project
- b. your track record in managing similar projects
- c. how the research team builds capacity by including researchers across career stages
- d. your access, or future access, to any required intellectual property, infrastructure, land, capital equipment, technology, and regulatory or other approvals
- e. how any infrastructure funded through this project will be maintained beyond the life of the grant opportunity.

H.4. Assessment criterion 4 (non-weighted)

Overall value and risk of the project

Your response is limited to 5000 characters including spaces and does not support formatting.

Your application should demonstrate the overall value and risk of the project, including that you have robust risk identification and management processes.

- You should provide:
- your Measures of Success statement
- your proposed budget and justification
- a risk management plan.

Our assessment will also take into consideration:

- the relative contribution of the outcomes or results you have identified against the MRFF Measures of Success to the objectives and outcomes of the grant opportunity as described in section 1.3
- the suitability of your proposed budget to complete all project activities
- how well the requested budget has been detailed and justified
- the value of any financial and/or in-kind contributions from partners
- how soundly your risk management approach is demonstrated
- any risks identified as part of the assessment of your application
- the appropriateness of the submitted risk management plan in documenting key risks to the completion of the research proposal, including your plan to manage those identified risks, and
- how you propose to monitor and report risks (both those identified in your submitted risk management plan and those which may arise during your project).

- Chief Investigator A, team and collaborators

In a table format list your Chief Investigator A and all collaborators who have shared authority and responsibility for leading and directing the design, conduct and reporting of the proposed project and include the affiliation of each person listed.

Include Title, Name, Position, Current Organisation, Email address and contact number

- Partner Contribution (where applicable)

List all partner contributions in a table format. Identify contributor, type of contribution (cash funding or in kind), total amount of contribution and value of contribution (per cent of total project cost).

- Risk management plan

A detailed risk management plan, and any supporting documentation, describing how you propose to monitor, manage and report identified risks including risks that may arise during your project

- Project feasibility analysis

Details of intellectual property (IP) arrangements as an attachment if this is not included within the written content of the application, if applicable

- Trust deed (where applicable)

Where you have indicated your entity type is a trustee applying on behalf of a trust, you must attach trust documents showing the relationship of the incorporated trustee to the trust.

- Evidence of support for your Board

You must provide evidence from your board (or chief executive officer or equivalent if there is no board) that your project is supported and that you can complete the project and meet the costs of the project not covered by grant funding.
