This document shows the questions included in the online application form for this grant opportunity. It will help you prepare your responses and the mandatory attachments you need before you apply online.

Instructions

The online form captures the information required by the department to assess and manage your application for services and funding.

The first page of the application page contains the following instructions.

Completing your application

The application consists of separate pages as shown in the navigation menu on the left hand side of the portal page. You can navigate between pages using the menu or the buttons at the bottom of each page.

A red asterisk * indicates a mandatory question. A warning message may appear if you have not completed all of the mandatory questions or if there is an issue with information you have entered.

Saving your responses

You can save your changes at any time by using the Save button.

To prevent you losing your work you should save often. The portal will time out after 30 minutes if you do not save. Typing or moving your mouse does not reset the time out.

You must use the Save and Continue button to validate the information on each page. If you use the menu to navigate between pages, you will be prompted on the final page to go back and validate all of the information you have entered. A green tick indicates a validated page.

You can modify saved responses up until you submit your application.

Participants

You may invite others to assist in completing your application via the application summary page. To do this:

- Select the Participants button
- Enter the details

An email will be sent to the participant inviting them to assist with your application.

Submitting your application

You must complete every page of the application before you can submit.

You must also read and agree to the declaration which advises you of your responsibilities.

Check all your answers before you submit your application. After you submit, it will no longer be editable.

A. Program selection

Before you start your application, we need to first identify what type of entity is applying.

Some programs we offer allow entities without an ABN to apply. The form is designed to accommodate these entities. However for this grant opportunity, an ABN is mandatory. If you do not have an ABN this grant opportunity will not appear in the program selection at the bottom of the first page and you will not be able to continue.

If you are a trustee applying on behalf of a trust we will need details of both the trust and trustee.

A.1. Program selection

You must select from a drop-down menu the program that you are applying for. If you have been provided with an Invitation code, you will be able to enter it here which will select the program for you.

- Field 2 select Powering Australia Industry Growth Centre Expression of Interest

When you have selected the program, the following text will appear.

This grant opportunity will run over four years from 2023-24 to 2026-27.

The grant opportunity was announced as part of the Australian Made Battery Plan. Up to \$14 million is available for this grant opportunity.

The objective of the program is to establish the national Powering Australia Industry Growth Centre (PAIGC) to:

- support businesses looking to locally manufacture renewable technologies;
- encourage connections between critical minerals producers and renewables manufactures;
- facilitate partnerships between governments, research institutions, and industry to drive the development and adoption of renewable technologies in Australia;
- support businesses in navigating battery regulatory barriers; and

 support First Nations businesses to contribute to the development of renewable technologies though engagement of a First Nations Business Advisor.

The maximum grant amount is \$14 million.

You should read the <u>grant opportunity guidelines</u> and <u>sample grant agreements</u> before filling out this application. We recommend you keep the guidelines open as you are completing your application so you can refer to them when providing your responses.

You may submit your application at any time up until 5.00pm AEST on 19 June 2023. Please take account of time zone differences when submitting your application.

B. Eligibility

We will ask you the following questions to establish your eligibility for the Powering Australia Industry Growth Centre grant opportunity.

Questions marked with an asterisk are mandatory.

Are you non-income-tax-exempt? *

You must answer yes to this question to proceed to next question.

Are you registered for the Good and Services Tax (GST)?*

You must answer yes to this question to proceed to next question.

C. Applicant address

Expenditure on research and development, i.e. creative work undertaken on a systematic basis in order to increase the stock of knowledge, including knowledge of humankind, culture and society, and the use of this stock of knowledge to devise new applications.

Taxable income

Taxable income or loss as per your organisation's income tax return form.

Number of employees (headcount)

Number of individuals who are entitled to paid leave (sick and holiday), or generate income from managing your organisation. This should include working proprietors and salaried directors.

Number of independent contractors (headcount)

Number of individuals engaged by your organisation under a commercial contract (rather than an employment contract) to provide employee-like services on site.

D.2. Your ANZSIC code

Ensure your project description focuses on your project's key activities and outcomes. Outline what it is you are going to do and how it will benefit your organisation.

E.2. Detailed project description and key activities

This information will be included in your grant agreement if your application is successful.

Provide a detailed description of your project including the project scope and key activities.

Your response is limited to 5000 characters including spaces and does not support formatting.

Refer to the grant opportunity guidelines for information on program objectives and outcomes and consider how these align with your project.

E.3. Project outcomes

This information will be included in your grant agreement if your application is successful.

Provide a summary of the expected project outcomes.

Your response is limited to 5000 characters including spaces and does not support formatting. Refer to the grant opportunity guidelines for information on program objectives and eligible activities, and consider how these align with your project.

E.4. Project duration

Your project must be completed in line with the dates provided in the grant opportunity guidelines.

E.5. Grant amount

You must enter the amount of grant funding you are requesting. We will add GST to this where applicable.

The grant amount can be up to 60 per cent of eligible expenditure up to a maximum of \$14 million.

E.6. Project location

You must provide the address where your project will be undertaken and the estimated percentage of project value expected to be undertaken at that site.

F. Assessment criteria

We will assess your application based on the weighting given to each criterion and against the indicators listed beneath each criterion. We will only invite applications that score at least 50 per cent against each criterion to submit an application under Stage Two, as these represent best value for money.

If invited to submit an application under Stage Two, you will be asked to provide more detailed responses, and will be asked to provide evidence to support your answers.

F.1. Assessment criterion 1 (50 points)

Your response is limited to 7500 characters including spaces and does not support formatting.

Project alignment with program objectives and outcomes

Provide an overview of your proposed PAIGC, giving consideration to how it would:

- support local manufacturing of renewable technologies and commercialisation of local ideas
- create connections between critical minerals producers and renewable manufacturers to develop domestic battery and other renewables supply chains
- facilitate domestic partnerships between renewable technologies industry, research institutions, and governments
- improve business capabilities to navigate battery regulatory barriers, develop, adopt and export renewable technologies
- develop the skills and management capabilities of the renewable technologies industry and First Nation businesses
- support First Nations businesses to contribute to the development and adoption of renewable technologies.

First Nations organisations are encouraged to apply. Organisations able to demonstrate a track record of working with First Nations organisations to deliver outcomes will be viewed positively during assessment.

F.2. Assessment criterion 2 (50 points)

Your response is limited to 7500 characters including spaces and does not support formatting.

Capacity, capability, and resources to carry out the project

Provide an overview of your organisation, demonstrating:

- your access to personnel with the relevant experience and expertise required for the successful delivery of the proposed PAIGC, including management and technical staff
- your ability and/or experience in building and utilising connections across industry, research organisations, First Nations businesses and organisations, and government to deliver outcomes
- your ability and/or experience in supporting industry to develop, commercialise and manufacture local ideas.
- your organisation's ability to provide access to equipment or resources, services and support to businesses nationally, including in regional and remote areas.
